# The British Berrichon Sheep Society In-Lamb Ewe and Ewe Lamb Sale Schedule

## Entry Conditions and General Information

1. Sheep entered must be accompanied by an up to date M.V Certificate.
2. All Sheep must be registered with The British Berrichon Sheep Society and the animals individual pedigree number must be printed on their tag.
3. All sheep must be tagged in accordance with the relevant DEFRA regulations. The Vendor shall be responsible for the correctness of identity.
4. All sheep forward for sale will be subject to a Society Inspection. Any animal which does not reach the Inspection standard will not be allowed to go forward for sale and must be removed from the sale pens. The Inspectors decision will be final.
5. All Pedigree Certificates **must** be forwarded with the Entry forms entries will not be accepted without the certificates.
6. **Entry Fees** - £16.00 including VAT per head will be charged. Cheques to be made payable to The British Berrichon Sheep Society and must accompany the completed entry forms to be returned to the secretary by **12th October 2023**. Late entries will not be accepted.
7. All entries forward for sale will be weighed and the following minimum weights will apply:

<b>Females:</b>	<b>Shearling Ewe</b>	<b>70 kgs</b>
	<b>Ewe Lambs</b>	<b>45 kgs</b>
8. Vendors may enter the following animals per class:  
3 x Aged Ewes  
  
No restriction on Shearling Ewes or Ewe Lambs but please see note 9 below.
9. The Society reserves the right to restrict entries if numbers entered in a particular class are too high. Sheep will be sold in maximum runs of 6. If more than this are entered in a class, the entries will be split into separate runs.
10. All sheep to be sold singly and will be sold in guineas.
11. The upset price will be as follows:

<b>All Aged &amp; Shearling Ewes:</b>	<b>250gns</b>
<b>Ewe Lambs:</b>	<b>200gns</b>
12. Each Vendor will be entitled to a page in the Catalogue to include an Introduction to their flock and if so wished a picture may be included in this.
13. **Substitutes will be allowed at the following ratios: 1-5 entries: 2 Substitutes, 6-10 entries: 3 Substitutes, 11+ entries: 4 Substitutes. Substitutes must be notified to the Secretary 48 hours prior to the Sale and these animals will have a coloured neck tie placed on them at the time of Inspection. Substitutes not notified to the Secretary will not be permitted for Sale and must be removed from the Sale area.**
